**RE: AZURA-EDO IPP STATUTORY OUTAGE PLAN AND GAS SUPPLIER OUTAGE NOTIFICATION**

We write with respect to the above-referenced subject.

This is to notify you of a revision to Aura-Edo IPP annual maintenance plan and gas supplier outage schedule. In our previous communication dated 31<sup>st</sup> July 2023, we had indicated that our gas supplier had proposed a 21-day major maintenance outage scheduled for the 2<sup>nd</sup> Quarter 2024.

However, we have received a revised forecast from our gas supplier, informing us of a turnaround maintenance of its facility between 12<sup>th</sup> August to 25<sup>th</sup> August 2024. Consequently, it is necessary for us to align both parties' maintenance activities within the terms of our contract and to ensure a reduction in overall statutory outage days.

Please see below the revised scheduled maintenance outages for the Azura-Edo IPP:

GT 11	12 <sup>th</sup> – 16 <sup>th</sup> August, 2024
GT 12	16 <sup>th</sup> – 20 <sup>th</sup> August, 2024
GT 13	20 <sup>th</sup> – 25 <sup>th</sup> August, 2024

Kindly note that these dates are tentative, and the actual outage date and timing is subject to technical and operational events and might differ from our best estimate proposed above.
